I understand bucking stock cattle present at this sale shall meet the following requirements:

BULLS:

Tuberculosis: Negative test within 365 days for all animals over 12 months of age in the name of the current owner.

Exception: If bull is from a **Modified Accredited Advanced TB State** (Michigan Counties of Alcona, Alpena, Montmorency, and Oscoda) the negative test must be within 60 days of the sale.

Trichomoniasis: Negative test within 60 days of sale. Bulls less than 18 months of age may sell without a test if there is a statement on the Certificate of Veterinary Inspection(CVI) stating the bull has not been exposed to female cattle since weaning.

COWS: Tuberculosis: Cows greater than 18 months of age from a **Modified Accredited Advanced state** (Michigan Counties of Alcona, Alpena, Montmorency, and Oscoda) must have a negative test for tuberculosis within 60 days prior to entry.

All bucking stock cattle assigned from out of state must have a Certificate of Veterinary Inspection(CVI) signed by an accredited veterinarian with USDA approved individual identification, breed, age, and sex of animal, and have a permit number assigned from the Oklahoma Department of Agriculture, Food, and Forestry (405-522-6141). Exception: If the CVI is Global Vet Link or AgView no permit is necessary as long as all the required ID and testing information is listed.

A spreadsheet is available on the OK Dept of Agriculture website as a guideline for the following required information:

Name, full address, phone number of seller.

Name, full address, phone number of buyer.

Individual ID by USDA approved ear tag for the animal.
