## NOTICE OF THE DRAFT CONCENTRATED ANIMAL FEEDING OPERATION GENERAL PERMIT AUTHORIZATION NO. OKG010225

Pursuant to the Oklahoma Agriculture Pollutant Discharge Elimination System (AgPDES) Act and Oklahoma AgPDES Rules (OAC 35:44), notice is hereby given that the Oklahoma Department of Agriculture, Food, and Forestry (ODAFF), at the address listed below, has processed and issued a draft permit authorization including permit terms to Tumbleweed Investments, LLC – Farm BGF1 based on the notice of intent (NOI) submitted on the 29th of June, 2017, for coverage under the Agricultural Pollutant Discharge Elimination System General Permit OKG010000 for Discharges from Concentrated Animal Feeding Operations (CAFOs). No discharge of pollutants into the waters of the state is authorized by this general permit except under a 25-year, 24-hour precipitation event or greater. All waste and/or wastewater will be beneficially used on agricultural land and/or transferred off site for beneficial reuse. The Tumbleweed LLC operates an 8,814 head swine CAFO facility at Farm BGF1, under the Standard Industrial Classification Code 0213. The Farm BGF1 facility is located in the N½ of Section 28, Township 4 North, Range 20 East, C.M., Beaver County, Oklahoma. The Farm BGF1 facility is located in the drainage area of the North Canadian (Beaver) River (Waterbody ID No. OK720500020450) in Segment No. 720500 of the Panhandle Region Basin. The designated beneficial uses of the potential receiving water(s) are fish and wildlife propagation/warm water aquatic community, agriculture, primary body contact recreation, aesthetics, and fish consumption.
