The Oklahoma Department of Agriculture, Food & Forestry (ODAFF) is NOT a national distributor of poultry supplies.

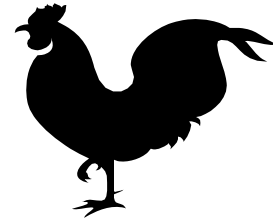
