


- Username requirements: Can contain Letters, digits, and only the following special characters @/./+/-/
- Please use correct and real email address. This email will receive important information regarding the sensitive crop viewer and registry.
- **Contact phone must be entered using dashes (-). i.e., 405-555-5555**
- Password requirements:
  - Needs to be at least 8 characters long.
  - Cannot be entirely numeric.
- Once you hit “Submit”, you will receive a confirmation email to the email provided during registration.  
**Note:** The information used to create your account will pre-populate the Sensitive Crop Form every time the user logs in (see below).

### 3.) Now you can login to the Sensitive Crop Registry and register your crop(s)!

- Fill in the Username and Password with the credentials you created when registering as a new user.
- **If you forgot your password and/or username click on “Reset it” and enter the email address you used to register your account and you will be sent an email with your information.**

### 4.) Filling out the Sensitive Crop Registry Form.

- Once logged in, the form appears as below. The information you used to create an account will pre-populate the form!



Please choose the most center point of the crop.

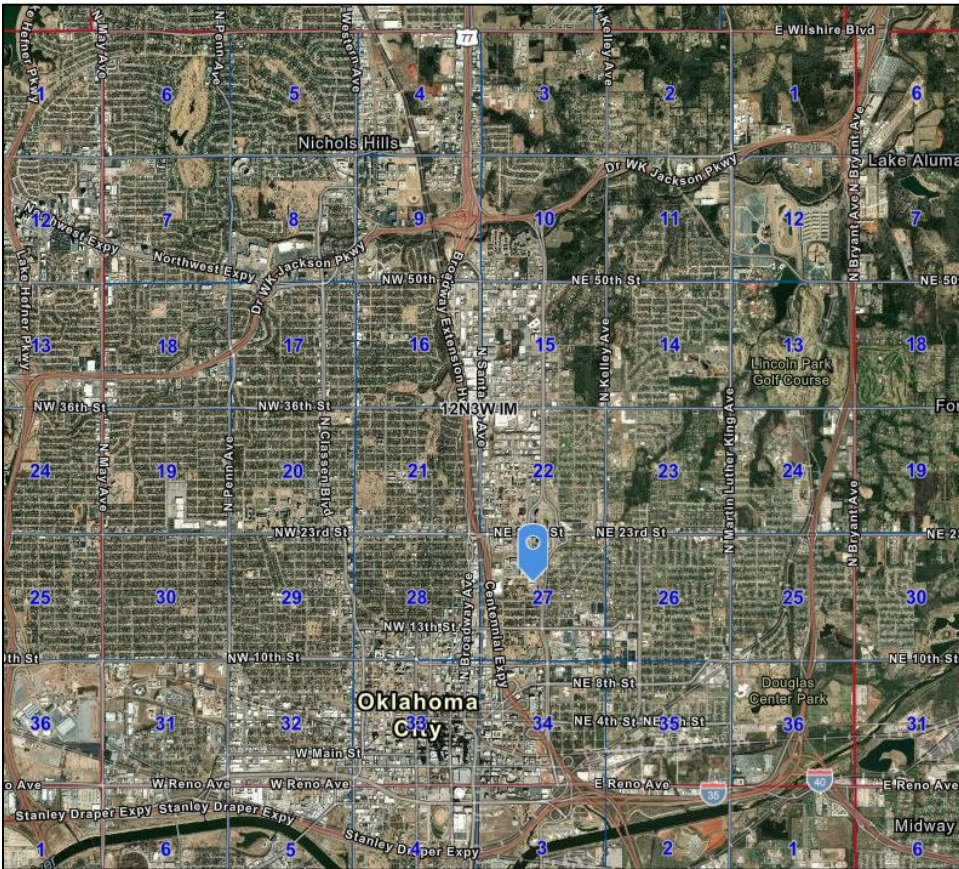
